accomplishment of the activities so that the voters shall not be deprived of their suffrage;

**NOW, THEREFORE,** the Commission **RESOLVED**, as it hereby **RESOLVES**, to amend the date for the posting of the certified list of voters to the following:

February 28, 2013	Posting of the certified list of voters (Sec. 30. RA 8189), in relation to sec. 28 of RA 8436	


